We are always looking for innovative ways to civically engage underrepresented communities. Last month, we launched our Agents of Discovery LA City Hall campaign as part of a SoCal Explorer 2.0 Campaign that includes missions not only in Los Angeles, but all throughout Southern California. Kids will now be able to come to City Hall and play a game to learn a bit about how government works in LA. Citywide Campaigns

We are assisting the LA County Clerk with their [Vote Center Placement Project](#) in LA City. In 2020, Los Angeles County will transition from traditional polling places to vote centers, which will increase the availability and accessibility of voting opportunities for LA-area voters. Unlike traditional polls, voters will be able to register same-day at vote centers, and they will be able to cast their ballot at any location in LA County over an 11-day period.

You're invited to attend one of the County's upcoming community meetings to share your thoughts on the placement of these centers. EmpowerLA is pleased to present the [Department's 2019-2020 Budget Proposal](#). The Department is submitting a Proposed Budget for FY 2019-20 of \$4,840,938 with a 68.2% (\$1,962,232) increase from the Department's Approved FY 2018-2019 budget. This budget ask focuses on (1) building the first phase of the Office of Civic Engagement, (2) expanding the administrative support for Neighborhood Councils and Department to handle the increased and varied workload, and (3) increasing the influence of underrepresented populations in the Neighborhood Council system. Many thanks to our budget team, Armando Ruiz, Semee Park, Tom Soong, Mike Fong, Kori Paraga and Man-Qin He for their work in writing the budget proposals and to our creative team, Sevak Paramazian, Arin Abedian and Ann-Marie Holman for the wonderful design! The budget proposal now goes to the Mayor's Office and CAO for review and hearings before being the Mayor releases his proposed budget on April 20, 2019. After that, the City

Council's Budget and Finance Committee will make their recommendations on any changes in order to approve the budget in May.

As we wrap up the calendar year, we want to thank our NCs and encourage folks to start thinking about 2019. With the 2019 NC Elections just around the corner, what outreach events does your NC have planned? Remember, to plan and to submit the [Events Approval Form](#) well in advance. It is advised to give 60 days lead time for any event so that there is ample time to secure the necessary permits, proof of insurance and to work out any issues so that you are not scrambling at the last minute.

Speaking of NC Elections, the Department will be hosting IgniteLA Elections Workshops to train women to run for board seats during the upcoming NC Elections. Workshops will be held on Saturday afternoon from 1 pm - 3 pm and will be held Citywide: Central & East 1/5 & 1/12, Valley 1/19 & 2/2, West 2/16, Harbor 3/2, South 3/9 and Monday 3/11 in City Hall.

After the mid-term elections in November, our citywide outreach plans will begin as we start our social media campaign and targeted local outreach for Neighborhood Councils who have had low voter turnout in the past. We will also activate our many community partnerships to begin candidate recruitment. We will be hosting a Citywide Outreach Gathering of Outreach Chairs and Community Groups on December 10th. Did you Know?

Did you know an applicant for a City cannabis license does not have to obtain the approval of a neighborhood council as a condition of receiving a license? Nor does an applicant have to enter into a community benefits agreement or any other agreement with a neighborhood council prior to obtaining a license. However, applicants and neighborhood councils are free to engage with one another, and applicants can enter into agreements to support the community. To vote on Neighborhood Council funding items, Neighborhood Council board members must have current ethics training and funding training. The Neighborhood Council bylaws may also require these trainings to vote for nonfunding items as well. To serve on a board, Neighborhood Council board members must also have either read and signed a Code of Conduct or have watched the video. To complete these trainings, please click [here](#).

NOTE: in person and online ethics training must be a minimum of 2 hours. If you complete the ethics training online, please ensure that you take 2 hours to complete the training as we will not accept any certificates that show less than 2 hours.

Funding - Eligibility to Vote on Financial Matters a. To be eligible to vote on any NC Expenditure, Financial Reports, and/or annual budgets, the board member must:

- Be an Elected, Appointed and/or Selected Board Member of the NC
- Be 18 years of age or older
- Have completed the California State Ethics Training Requirement for Local Officials (AB 1234)
- Have completed the online NC Board Member Funding Training and obtain a passing score of 70% on any test associated with the online course.
